The deadline for requiring a REAL ID compliant credential to board a domestic airline flight has been extended to May 3, 2023. Until that date, TSA will accept any state-issued current Oklahoma driver license or identification card. The deadline extension does not apply to other federal facilities that currently require REAL ID compliant credentials to enter, such as military bases or federal buildings.
